

Binding Suspension for Massachusetts & Updated Suspension for California & Nevada

Massachusetts - Heavy Snow, Flooding, and High Winds *New

Please be advised we are suspending all quoting, binding, and issuance for all lines of business (including Recreational Marine) in Barnstable County, Massachusetts, as a result of heavy snow, flooding, and high winds.

In addition, we are also suspending all quoting, binding, and issuance of Primary and Excess Flood coverage, as well as Recreational Marine, for the following counties: Dukes, Essex, Nantucket, Plymouth, Suffolk, and the Cohasset part of Norfolk Territory 63 (the Recreational Marine suspension applies to all of Norfolk County).

This suspension applies to any new business, new location, increase in coverage or exposure, and decrease in deductible.

Please be advised we are updating this suspension to apply to all lines of business (including Recreational Marine) in Butte County, Yuba County, and the following Sutter County zip codes: 95991, 95992, and 95993.
