Comprehensive Safety Analysis (CSA) 2010 safety management system

CSA 2010 is a new Federal Motor Carrier Safety Administration (FMCSA) safety program to improve commercial fleet safety and ultimately reduce crashes. It introduces a new enforcement and compliance model that allows FMCSA and its state partners to contact a larger number of carriers earlier in order to address safety deficiencies before crashes occur. ESIS fleet specialists have extensive experience working with the Behavior **Analysis and Safety Improvement** Categories (BASICs). ESIS has developed a Safety Management System (SMS) audit program that can be used to ensure that your fleet is in compliance with all of the BASICs. The audit process will also inform the company on how they can go beyond the minimum standards of each BASIC to see even greater improvement in losses.

Customized fleet driver training
