## What We Have Paid Lately

- During a shipment from California to Indiana, the trucking company subcontracted the load, and the goods were never delivered to the final destination. The DOT information was hacked on load boards, with thieves impersonating the trucker. The thieves stole the load, and a second truck load was stolen under the same occurrence. Chubb paid \$450,000 across various claims.
- Our insured's goods were being transported by cargo ship when it struck a bridge and was stranded in the harbor. A General Average loss was declared, and the insured's undamaged containers were impounded. Chubb posted a Guarantee Bond for the full \$950,000 value of our insureds Cargo, and they were released back to the insured. The final loss settlement to share in the costs of debris removal, ship damage, and towing costs will likely take several years to adjudicate.
